LHCP Update

LHCP Reaches Milestone—100,000 Pounds

Thanks to the 40+ boxes that were shipped on October 6, LHCP reached and surpassed a significant milestone—100,000 pounds of comfort and care items have been shipped to Landstuhl Regional Medical Center (LRMC) and combat support hospitals!

What does this milestone represent?

It represents a simple response to wanting to provide entertainment for hospitalized troops when the initial shipment was a box of VHS tapes.

It represents follow up as the chaplains at LRMC were consulted about what do patients at LRMC need "this month."

It represents a mother of a fallen soldier finding her son's name in a Google search in which he is listed as an Honoree for an organization she never heard of... LHCP.

It represents many loving stitches and knots as supporters have made countless blankets, pillows, med bags, scrub hats, Christmas stockings, and other requested items.

It represents growth that sprouted as word spread, as our 501c3 tax-exempt status was obtained, as patient liaisons returned to their deployed units and spread the news about a helpful organization called LHCP.

It represents how a planted seed can sprout and grow, and a home can become a receiving office, warehouse, and fulfillment/distribution center.

It represents generosity... of children, families, youth groups, school groups, church groups and congregations, civic

organizations, veterans organizations, CFC contributors, people living in other countries, coworkers, and businesses.

It represents family and friends who give contributions in honor of troops currently serving, in honor of military veterans, and in memory of loved ones who served.

It represents trips to LRMC where patients were challenged to not leave the Wounded Warrior Ministry Center without taking at least one item; where donations were organized and sorted; and where a hug or listening ear were waiting for patients, liaisons, medical personnel, or chaplains—with hours worked in honor of LHCP supporters.

It represents support for hard-hit medical facilities that received LHCP shipments just as critical items like sheets, blankets, and pillows were in short supply, giving solace in knowing the troops were remembered "back home" and that the fallen were not forgotten as they posted oft-read Honoree labels in work areas.

It represents the need that still exists as fierce fighting continues in Afghanistan and terrorists and insurgents plot and attack in Iraq and other parts of the world.

As long as troops are in harm's way, may LHCP continue to draw support so that we can continue to provide comfort and care items to our troops who become wounded, injured, or sick and to support the military medical personnel who care for them.

State Charitable Organization Registrations

As a non-profit organization with a 501(c)(3) tax-exempt status, LHCP is a public charity where financial and in-kind contributions are tax deductible for our donors.

LHCP is registering as a non-profit 501(c)(3) charitable organization in the individual 50 U. S. states, the District of Columbia, and Puerto Rico, one state at a time.

The task of registering LHCP in each state varies greatly. Some states do not require non-profit charitable organizations to register within their state. Some states require initial registrations with no annual renewal. Some states require annual renewals—and renewal dates differ from state to state.

Some states require non-profits to register only if they are under contract with a “professional fundraising” solicitation or solicitation company. *LHCP does not contract or use any type of professional fundraising solicitation practices, contractions, or employees to solicit contributions.*

LHCP receives financial and in-kind donations by word-of-mouth, the CFC campaign, and through our internet web site. LHCP does not hold fundraising events. There are citizen efforts, community projects, and organizations that conduct fundraising activities and provide donations to LHCP.

Each state has its own set of document requirements, with many states looking for similar information, but on different forms. Generally, the registration process includes completing the state

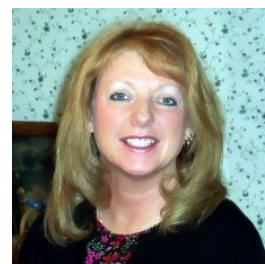
registration forms, our IRS 501(c)(3) determination letter, corporation certification, articles of incorporation, bylaws, most current IRS Form 990, and annual financial audit. In some cases, our original IRS Form 1023 (application for 501(c)(3) status) and our Annual Report is required. To add to the effort, some states require documents to be notarized. The State of Georgia, requires criminal background checks on the President, Vice President and Treasurer. So you can see, the process can take some time and effort.

The individual state registration process has costs involved. These costs are considered as administrative expenses when it comes to reporting expenses to the IRS. The costs for printing the state forms and all the necessary supporting documents have been donated along with some of the postage fees and notary fees in order to keep the administrative costs to a minimum for this effort.

A great majority of the states require registration and annual renewal fees—ranging from \$25 to over \$200. In some cases, the fee is based on the amount of annual contributions revenue listed on our latest IRS Form 990. All registration and annual renewal fees are paid by LHCP.

LHCP is a 100% volunteer organization with no paid salaries or compensation for goods and services. LHCP strives to keep our administrative expenses under 10% of total contributions. LHCP’s 2008 IRS Form 990 reports our administrative expenses were 3% of all contributions made in 2008.

When compiling the last three reports for IRS 990 (2006, 2007, and 2008), LHCP’s administrative expenses averaged 3% of contributions made.

Once all the states are registered and we are renewing within those states annually, LHCP will experience an increase in administrative expenses. These are expenses we can’t avoid so that we are registered where we need to be.

The state registration process is ongoing. Currently, we are registered in Alabama, Arizona, California, Florida, Maryland, New Jersey, New York, North Carolina, Ohio, Oklahoma, South Dakota, Utah, Virginia, Washington, and Wisconsin. The pending state registrations are Michigan, Pennsylvania, and Tennessee. Paper work is currently being processed for Missouri, Texas, Colorado, Connecticut, and Minnesota. The remaining states will follow.

As the LHCP Treasurer, I would like to send a big thank you to all our members and contributors for their dedicated efforts to support the mission of LHCP. Your generous contributions, whether it is your time, your in-kind donation or your financial contribution, makes the efforts of LHCP a success. Your part in this effort brings a little bit of home to those military service members serving our county so far away from home. THANK YOU!
